- May 2021 - Student surveys were administered via Google Forms and Panorama
- August 2021 - Consulted with Special Education administrators
- August 2021 - Consulted with school and district administrators
- September 2021 - Consulted with teachers, Certificated Local Bargaining Unit, administrators, and principal at the regularly scheduled weekly meetings
- September 27-October 7 - Public Comment Period
- September 2021 - English and Spanish stakeholder surveys were disseminated to families, including families that speak languages other than English. Families include parents, legal guardians, community members, and students. Completed surveys were returned to the school office.
- September 2021 - Surveys were disseminated to teachers. Completed surveys were returned to the school office.
- September 2021 - Surveys were disseminated to school staff, including all classified staff and administration/school leaders/principle. Completed surveys were returned to the school office.

October 14, 2021 – All community members' input, including parents, students, and staff input, was considered. The ESSER III Expenditure Plan was approved and adopted by the Board of Trustees.

Pacific Union does not have a Classified Union.

Input from the community member groups was instrumental in the development of the ESSER III Expenditure Plan. Each group provided valuable information regarding the needs and services for all students, including our socio-economically disadvantaged, Foster Youth, English learners, students of color, and students with disabilities. Information was gathered through meetings and surveys distributed schoolwide in English and Spanish.

A description of how the development of the plan was influenced by community input.

Input from the community member groups was instrumental in the development of the ESSER III Expenditure Plan. Community engagement offered valuable information regarding the use of ESSER III funds to increase the health, safety, services for all students, including our socio-economically disadvantaged, Foster Youth, English learners, students of color, and students with disabilities.

The feedback received influenced the following actions:

- Facility Maintenance - 75% of family surveys and 59% of staff surveys favored facility repairs and improvements to enable the operation of the school to reduce the risk of virus transmission and exposure to environmental health hazards, and to support student health needs. 64% of staff and students favor using the funds to purchase supplies to sanitize and clean the facilities. Input from teacher and staff meetings support inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school classrooms and facilities.
- COVID-19 Contact Tracing Liaison and COVID-19 Screening and Testing - Comments from meetings and surveys requested ESSER III funds be used to pay for on-campus COVID-19 testing, screening, and contact tracing. The implementation of a COVID-19 Contact Tracing Liaison has contributed to the sense of safety families feel in sending their children to school. 96% of students have returned to campus for in-person instruction.
- Hire More Teachers to Accelerate Learning - 68% of family surveys and 60% of staff surveys favor learning supports, such as tutoring or similar small group instruction. Input from meetings supports smaller class sizes to provide increased targeted small group instruction to accelerate learning.
- After School Programs - 70% of family surveys favored implementing an afterschool program. Only 45% favored continuing an extended school day, which was implemented for the 2021-2022 school year.

All of the feedback mentioned here from the community engagement was included in this plan.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption.
